1. SCPa Works Overview and Background

The South Central Workforce Development Board (SCPa Works) comprises the counties of Adams, Cumberland, Dauphin, Franklin, Juniata, Lebanon, Perry, and York in South Central Pennsylvania. SCPa Works has branded a region where all residents have the opportunity for prosperity through the cultivation and establishment of nationally recognized initiatives across all aspects of workforce development. SCPa Works' mission is to unlock the human talent that drives the development of businesses and individuals to achieve common goals.

SCPa Works serves as the fiscal agent in funding results-driven employment and training programs across the region that increase the scope of job seekers in obtaining new skills and career opportunities while allowing businesses to accelerate business growth potential through building effective talent pipelines that meet workforce demands. SCPa Works invests nearly \$14M into high impact employment and training programs for youth and adults across South Central PA.

2. Scope of Work

SCPa Works is seeking the services of a qualified Geographic Information Systems (GIS) Analyst to support ongoing mapping and analysis support in a workforce development context. The successful candidate or firm will provide technical GIS expertise, spatial data analysis, and map production to support current and upcoming projects. Specifically, projects will contribute to SCPa Works' ongoing Community Access Point Strategy, a place-based approach to effective service delivery in the eight-county South Central region.

The GIS Analyst will be expected to:

- Develop, manage, and maintain geospatial databases.
- Analyze spatial data and generate reports, maps, and visualizations.
- Perform geoprocessing and spatial analysis tasks using software such as ArcGIS Pro. SCPa Works will provide software licenses.
- Integrate data from various sources for mapping purposes.
- Ensure data accuracy, documentation, and compliance with organizational standards.
- Document and compile data sources used for projects.
- Provide detailed narrative/interpretation of final maps and reports for the general public, SCPa Works staff, and relevant stakeholders.
- Utilize external data sources such as the US Census, Lightcast, and CWDS (Commonwealth Workforce Development System) for mapping purposes.

3. Deliverables

The selected individual or firm will be expected to deliver:

- A project work plan and timeline.
- Weekly or biweekly status updates.
- Final maps, data layers, and accompanying documentation.
- A closing report summarizing the GIS contributions to the project.

4. Minimum Qualifications

- Bachelor's degree in Geography, GIS, Environmental Science, Urban Planning, or related field.
- In place of a degree, 2+ years of experience performing similar duties.
- Proficiency with GIS software (ArcGIS, QGIS, etc.).
- Strong analytical, problem-solving, and communication skills.
- Experience with data visualization, spatial analysis, and GIS database management.
- Familiarity/experience working with workforce development boards and/or WIOA (Workforce Innovation and Opportunity Act) performance metrics is a plus.

5. Proposal Requirements

Interested applicants should submit the following:

• Cover letter outlining experience and approach.



- Resume or CV (or company profile for firms).
- Portfolio or examples of past GIS work.
- Hourly rate or fee structure.
- One (1) reference.

Total proposal length should not exceed seven pages.

6. Contract Type

This contract will be structured as a fee-for-service agreement for up to two (2) years from the execution date. Under this agreement, the selected contractor will provide Geographic Information Systems (GIS) analytical services as needed, with work assignments issued intermittently throughout the contract term.

The work is project-based and may be sporadic, meaning there will not be a guaranteed or consistent level of work throughout the full two-year period. Instead, specific tasks or deliverables will be requested as needs arise, and the contractor will be compensated only for services performed and approved.

Each assignment or task order will include a defined scope of work and timeline. The contractor must be available to respond to these requests promptly, subject to mutual agreement on schedule and availability. Compensation will be based on the agreed hourly or per-task rate outlined in the contract, and no minimum number of hours or projects is guaranteed.

This arrangement allows flexibility for the organization and the contractor, accommodating shifting project timelines and resource needs while ensuring access to qualified GIS expertise when required.

7. Submission Deadline

8. Evaluation Criteria

Proposals will be reviewed and evaluated by SCPa Works staff based on:

- Relevant experience and qualifications.
- Quality of past work samples.
- Cost-effectiveness of the proposal.
- References
- Demonstrated understanding of the project needs.



9. Award of Contract

Each respondent submitting a proposal will be notified via e-mail of SCPa Works' decision. Formal notification to award a contract and the actual execution of a contract are subject to the following conditions:

- Receipt of funds from federal and state administering agencies;
- Results of negotiations between the selected vendor and SCPa Works management;
- Continued availability of SCPa Works funds; and
- Approval by the SCPa Works Board of Directors.

SCPa Works shall award a contract to the responsible and responsive applicant(s) whose proposal is determined to provide the best overall value to SCPa Works regarding ability to perform the required services, experience, and cost.

The applicants must provide details in the proposal regarding the reasons for objection to any part of these terms and conditions and provide alternate language. Time is of the essence when awarding a contract. A hindrance to the award process due to the extent of an applicant's proposed modifications may negatively impact SCPa Works' assessment of that proposal.

No portion of these services may be subcontracted without prior SCPa Works approval. The contract resulting from the award of this Request for Services will consist of this Request for Services (which includes SCPa Works and Fiscal Agents General Conditions), the proposal, and any additional information deemed necessary as a result of the negotiations held with the successful applicant(s).

The successful applicant(s) will be required to enter an agreement with SCPa Works in the form attached hereto as Exhibit A to ensure compliance with the provisions of WIOA, its regulations, applicable laws and regulations promulgated by the Commonwealth of Pennsylvania, and SCPa Works policies, which shall comprise the terms and conditions of the award.
